# **Terms of Service**

### 1 Definitions

'We' or 'Us' refers to Lucid Information Systems. 'You' or 'Your' refers to you, the client, interacting with us in any way.

#### 2 Introduction

These terms and policies will apply to every use of Our products and services. We reserves the right to issue revisions to these Terms / Policies by publishing a revised version of this document: that version will then apply to all use by You following the date of publication. Each access of information from Us will be a separate, discrete transaction based on the then prevailing terms.

#### 3 Late Fees

Invoices paid later than 45 days after the issue date of the invoice will incur a \$20.00 or 10% late processing fee (which ever is greater), unless previously arranged verbally or in writing that that particular invoice can be paid late.

Any fees not paid after 60 days past the issue date of the invoice may be referred to a debt collection agency, and further late fees may be incurred as per the costs involved with debt collection.

#### 4 Projects

It is important to discus projects before they commence, so that we have a clear understanding of what You would like. The project discussion process increases the likely hood of project success.

Projects will normally require specifications to be drawn up, to clarify the project details and possibly the project goals. Study of the project specifications may uncover potential issues, before they are reached or the project is undertaken.

Any pricing estimate for a project expires after 14 days. Any estimate (price, time, or otherwise) may be incorrect, depending on the material that the estimate is based on.

A non-refundable deposit (a minimum of \$100, or 20% of the estimate which ever is greater) is required to begin work on new projects. Projects are billed fortnightly (invoices are due upon receipt, unless otherwise arranged) and the balance is due upon completion of the project.

A failure to pay on time may result in withholding the assets of the project from the client, and/or termination of the project.

An initial specification for the project must be submitted. The initial estimate will be based on this. Any further changes must be submitted and will incur extra cost.

A bug fix will incur extra cost unless it is resolving a clearly incorrect interpretation of the project documentation.

#### 5 Pricing

#### 5.1 Pricing and Quotes

Our website is the most up-to date reference for our product and services pricing information. Pricing information available from our website is for our most basic products and services. Many of Our products and services are related to third parties. When quotes are drawn up, we will contact appropriate third parties, and then be able to provide more accurate pricing information for our services or products. In order to deliver a product or service third parties may be involved, we can not be responsible for the their actions, inactions, products, services or alterations to prices.

It is important to note that we charge different rates, depending upon the work undertaken.

Project planning is important to Us, it means that You know what to expect from Lucid Information Systems. Projects<sup>1</sup> may initially seem simple, however there may be many complications which are not at first apparent. Project planning attempts to highlight these issues, allowing them to be included in quotes. This process reduces the risk that a project will be over budget or be lacking an important feature.

#### 5.2 Sales Tax

#### 7 Beta Release of Products and Services

Our Beta products and services are not production ready. Beta implies that there known issues with the product and/or service. By using Our beta products and/or services You are testing products and/or services which are still in a development phase.

"A beta version is the first version released outside the organization or community that develops the software"<sup>3</sup>.

"The users of a beta version are said beta testers. They are usually customers or prospective customers of the organization that develops the software. They receive the software for free or for a reduced price, but act as free testers"<sup>4</sup>.

By using Lucid Information Systems beta software or services in any way you become a beta tester. If you do not want to be a Lucid Information Systems beta tester then you must not use any of Our beta products and/or services.

Currently any information You supply to us via the Internet will be not be encrypted. Therefore We can not be held responsible for any information which is stolen during transit or from our server by a cracker. Security is important to Us, therefore We perform regular security checks to minimize these risks.

If You would like to use encryption to provide an additional layer of privacy to Your communications with Lucid Information Systems this can be arranged. Simply contact Us via an unsecured communication method; We will then assist You with the setup of encrypted communications. If You are already familiar with PGP, then You may download our public key from our website.

In order to maintain deployed systems, communications between our deployed products and our monitoring/update stations will need to be established. If You have Lucid Information System product(s) on site these devices may communicate with our server for monitoring and/or update purposes. If You do not want these monitoring and/or update services it is important that You express to Us that You do not want any out bound or in bound communications with our monitoring/update stations. This will result in monitoring and update services being disabled resulting in such services being unavailable You unless You decide to allow such communications to take place, or if You request activation of a service which which requires such a service or depends upon such a service. At which point the communication links between our servers and deployed products will need to be re-established.
